ABSTRACT

This report presents national estimates of discharges from the 2012 HCUP National Inpatient Sample (NIS) for records with a primary expected payer of Medicare compared to data from the Fiscal Year 2012 100% Medicare Provider Analysis and Review (MedPAR) inpatient file from the Centers for Medicare & Medicaid Services (CMS). The sampling frame for the NIS includes all U.S. short-term, acute care general and specialty hospitals, excluding long term care, rehabilitation, psychiatric and substance abuse facilities while MedPAR data include Medicare discharges from all of these types of facilities.

On average, CMS numbers of discharges are about 5 percent higher than NIS estimates. Among frequent conditions (more than 30,000 discharges in the NIS), only eight MS-DRGs, all of which are often treated in facilities excluded from the NIS, exhibit more than a 10 percent difference from MedPAR counts: MS-DRG 945-rehabilitation (35.1 percent lower in the NIS), 207-respiratory diagnoses with ventilator support 96+ hours (32.5 percent lower), 885-psychoses (30.6 percent lower), 897-alcohol/drug abuse (28.0 percent lower), 946-rehabilitation (25.1 percent lower), 57-degenerative nervous system disorders (12.2 percent lower), 884-organic psychiatric disturbances (10.7 percent lower), and 473-cervical spinal fusion (10.5 percent lower).

For many common conditions, the NIS estimates and the CMS counts are remarkably similar. For the second most common DRG, 871-septicemia, the NIS estimates 1.5 percent more discharges than the CMS count. For 392-esophagitis, ranked 4th, the NIS estimates 2.9 percent fewer discharges. For 292-heart failure with complications and comorbidities (ranked 5th) and 690-kidney & urinary infections (ranked 6th), the NIS estimates 1.7 percent fewer discharges. For 194-pneumonia (ranked 7th) and 291-heart failure with major complications and comorbidities (ranked 8th), the NIS estimate and the CMS count differed by less than 1 percent.

The 2012 NIS appears to provide reliable national estimates of Medicare discharge counts when compared with MedPAR data.

INTRODUCTION


This report provides a brief analysis that compares estimates of discharge counts from the Healthcare Cost and Utilization Project (HCUP) National Inpatient Sample (NIS) for 2012 with Fiscal Year 2012 Medicare Provider Analysis and Review (MedPAR) inpatient data from the Centers for Medicare & Medicaid Services (CMS).¹ Comparison reports for prior years have shown that estimates of several outcomes from the NIS tend to agree well with corresponding estimates from multiple national databases. This report compares just one estimated outcome from the 2012 NIS, Medicare discharge counts, with counts from just one other database, the Fiscal Year 2012 100% MedPAR file. Although the scope of this comparison is more limited than comparisons in previous reports, it is nonetheless reassuring to see substantial agreement between estimates from these two data sources for such a significant subset of the inpatient population.

As shown in Figure 1, the 2012 NIS is selected from a sampling frame comprising 44 HCUP Partner organizations. Only six States, plus the District of Columbia, are not included in the 2012 NIS sampling frame: Idaho, Mississippi, Alabama, Maine, New Hampshire, and Delaware.

The findings in this report are summarized in tables that highlight differences and similarities in estimates of the 2012 discharge counts between the NIS and the MedPAR.

- Table 1 compares counts for the top 100 diagnosis related groups (DRGs).
- Appendices A and B provide estimates for the full list of all DRGs. For convenience, Appendix A contains a table sorted by DRG and Appendix B contains the same table sorted by the number of HCUP discharges (of which Table 1 represents the first 100 rows).

Summary of NIS-MedPAR Comparisons

- On average, CMS numbers of discharges are about 5 percent higher than the NIS numbers (bottom of Table 1). This discrepancy can be explained by the difference between the MedPAR universe and the NIS universe. The NIS is a sample of discharges from short-term, acute care community hospitals. In particular, the NIS excludes psychiatric hospitals, substance abuse facilities, rehabilitation hospitals, and long-term acute care (LTAC) facilities. Further, the NIS estimates are based only on discharges with Medicare as the first-listed (primary) payer, whereas the MedPAR count includes discharges with Medicare as a secondary payer. Even in the absence of these differences, we would expect to see some differences on discharge counts because the NIS counts discharges for the calendar year (January 1 through December 31,

2012) whereas the MedPAR counts discharges for the fiscal year (October 1, 2011 through September 30, 2012).

- These NIS exclusions most likely explain DRGs exhibiting more than a 10 percent difference. For example, large percentage differences occur for psychiatric-related conditions (ranked 3rd and 64th in Table 1), substance abuse (ranked 60th), rehabilitation-related conditions (ranked 9th and 57th), and LTAC-related conditions (ranked 45th, 81st, and 99th).
- NIS exclusions of long term care, rehabilitation, substance abuse, and psychiatric facilities are likely the underlying reason for differences for the most frequent conditions with the largest NIS-MedPAR differences. Among frequent conditions (more than 30,000 discharges in the NIS), only eight MS-DRGs exhibit more than a 10 percent difference from MedPAR counts:
 - 945-rehabilitation (35.1 percent lower in the NIS)
 - 207-respiratory diagnoses with ventilator support 96+ hours (32.5 percent lower)
 - 885-psychoses (30.6 percent lower)
 - 897-alcohol/drug abuse (28.0 percent lower)
 - 946-rehabilitation (25.1 percent lower)
 - 57-degenerative nervous system disorders (12.2 percent lower)
 - 884-organic psychiatric disturbances (10.7 percent lower)
 - 473-cervical spinal fusion (10.5 percent lower)
- For many common conditions, the NIS estimates and the CMS counts are remarkably similar:
 - 871-septicemia, ranked 2nd (1.5 percent higher in the NIS)
 - 392-esophagitis, ranked 4th (2.9 percent lower).
 - 292-heart failure with complications and comorbidities, ranked 5th (1.7 percent lower)
 - 690-kidney & urinary infections, ranked 6th (1.7 percent lower)
 - 194-pneumonia, ranked 7th (less than 1 percent difference)
 - 291-heart failure with major complications and comorbidities, ranked 8th (less than 1 percent difference)

In the complete tables contained in the appendices, there tend to be larger percentage differences for less common DRGs, but the same pattern continues as those found in Table 1: large differences tend to occur in DRGs that would be most affected by the exclusions of certain types of hospitals and facilities from the NIS sample (long-term acute care facilities, rehabilitation hospitals, and substance abuse and psychiatric facilities).

The 2012 NIS appears to provide reliable national estimates of Medicare discharge counts when compared with MedPAR data. Although the MedPAR data might be favored for studies addressing solely Medicare enrollees, the NIS would be favored for all-payer studies or even for special

Medicare studies in which the all-payer context is important, such as analyses of the impact of total surgical volume on surgical outcomes for Medicare patients.
